SER Limited (Solutions Engineering Recruitment Limited) are specialist recruitment consultants dealing with permanent, temporary and contract assignments throughout the UK.

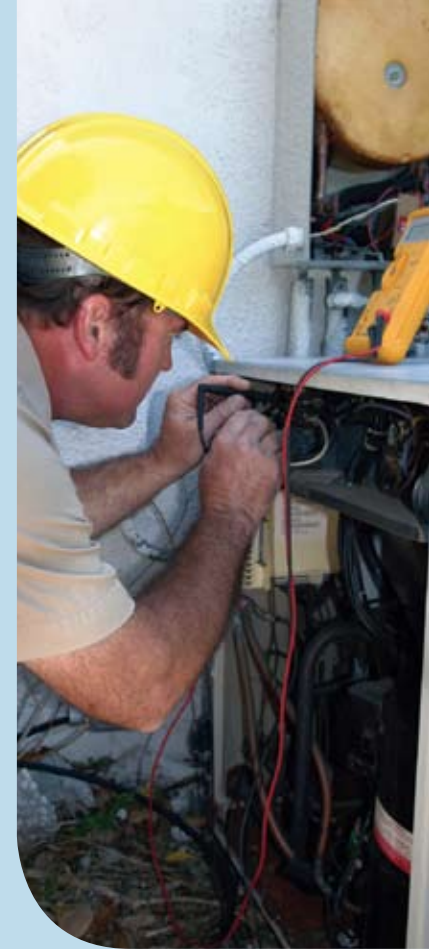
We are structured so that each of our industry consultants work within their own individual market sector and therefore hold an excellent understanding of the skills and experience required to work within that sector.
